Q. Can I choose my own eye care professional?

- A. You can **go to any licensed eye care professional**. Choose from thousands of participating professionals at private practices or popular retail locations,³ such as Visionworks, MyEyeDr, JCPenney Optical, Shopko, and more. Enjoy lower out-of-pocket costs when visiting a participating vision care provider.

Or visit online in-network eyewear stores, including Glasses.com, Befitting.com, and 1-800-Contacts.com.

If you choose an out-of-network provider, you will have increased out-of-pocket expenses, pay in full at the time of services, and will need to file a claim with MetLife for reimbursement.

Q. How can I find a participating eye care professional?

- A. You can find a participating eye care professional by using the Find a Vision Provider tool at MetLife.com through MyBenefits. Select Find a Vision Provider, choose Davis Vision by MetLife, complete the information requested and hit the Search Now button.

Q. What kinds of frames are available in my plan?

- A. Choose the eyewear that's right for you and your budget. Take advantage of a selection of fully covered frames at no additional cost to you, plus get access to the Davis Vision Exclusive Collection, with coverage on designer frames for \$40 or less and a one-year breakage warranty.

Q. What should I tell my provider at my next vision care appointment?

Q. What services are covered under my plan?

- A. Routine eye exams, frames and contact lenses are available with your plan at competitive group rates. Your plan also offers lens enhancement options including, but not limited to, polycarbonate (shatter-resistant) lenses, ultraviolet (UV) coating, scratch-resistant and anti-reflective coatings, and progressive lenses.

Q. What discounts can I get with my plan?

- A. Your plan includes a discount on laser vision correction.² Plus, you can get a hearing exam at no additional cost and a discount up to 40% off hearing aids.⁵

Q. Why do I see MetLife branding in my Davis Vision material?

- A. Recently, Davis Vision became part of the MetLife family of companies. You may see your new Vision benefits referred to as Davis Vision by MetLife.

Q. If I'm already enrolled in a vision plan administered by Davis Vision, will there be any changes to my benefits?

- A. No. This change is not expected to have a significant impact on your scope of benefits, or vision provider network. Please continue to enjoy your vision benefits and in-network providers as you have in the past. And while the scope of your benefits and provider network remain materially the same, there will be a couple administrative changes.

Q. What are the administrative changes now that MetLife is the parent company?

- A. Please note these administrative changes, beginning September 1st:

- **Telephone Number:** The new telephone number for vision benefits questions is **1-833-EYE-LIFE**. NOTE: All previous call center numbers remain operational and will work as well.
- **MyBenefits:** You will now have access to MetLife's MyBenefits website (www.Mybenefits.Metlife.com), an online location for all your benefit needs, including the Find a Vision Provider tool, claims history and access to a digital ID card.

Q. Who should I call if I have any questions about my Davis Vision benefits?

- A. The new telephone number for vision benefits questions is **1-833-EYE-LIFE**. NOTE: All previous call center numbers remain operational and will work as well.

Q. How do I access plan information online?

- A. After September 1st, securely register on MetLife's MyBenefits website at MyBenefits.MetLife.com to view your claims, print your digital ID card, review information about your plan and more.

Q. Do I need an ID card?

- A. No. You do not need an ID card to schedule an appointment or receive services. While ID cards aren't required, new ID cards will be available to you through MyBenefits.

When visiting a participating vision provider without an ID card, please be prepared to provide your name and date of birth.

Q. What if my provider is not part of the Davis Vision network?

- A. Your plan provides maximum benefits when utilizing providers that participate in the Davis Vision network. However, if you obtain services from a non-participating provider, you will be required to pay for your services up front and submit a claim for reimbursement. Out-of-network claim forms can be obtained online on the MyBenefits website at MyBenefits.MetLife.com, or by contacting member services at **1-833-EYE-LIFE**.
